The Global Alliance for Improved Nutrition (GAIN) is a Swiss-based foundation launched at the United Nations in 2002 to tackle the human suffering caused by malnutrition. Due to COVID19, conflict in Ukraine and climate change, malnutrition and hunger have worsened significantly since 2019, reversing a decade of progress. There is growing recognition that our food systems need to change if we are to reverse these trends.

GAIN's Strategy aims to transform food systems to make healthier diets from sustainable food systems accessible to all people and especially those whose are most vulnerable to shocks. By 2027, we aim to improve the access of 1.5 billion people to nutritionally enhanced staple foods, improve the access of 25 million people to healthier diets, and support positive food system change in 10 countries. This is bold and complex, and the only way to achieve this is to work together with partners including governments, businesses, and civil society at the country and global level. These goals, and the ways of achieving them, build on our twenty-year legacy of transforming people's lives with improved nutrition through concerted action and effective policy change.

Social protection schemes help to mitigate vulnerability, reduce poverty, and provide affordable healthcare and insurance to low-income families. GAIN's social protection approach emphasizes community-based approaches, human-centred design, and social and behaviour change as tools for enhancing the nutrition impact of social protection. As part of GAIN's global social protection programme, we are establishing a co-innovation platform for nutrition-sensitive social protection, which will enable national and sub-national social protection administrators from various country contexts to engage in South-South knowledge exchange, and to form co-innovation partnerships to tackle issues of shared interest toward improving the nutrition impacts of social protection.

DESCRIPTION

Overall purpose

The internship will support operationalization of the first cohort of co-innovation partnerships in the Co-Innovation platform. Through engagements with GAIN country teams and key stakeholders, capacity-building needs will be assessed, and a set of key topics will be identified as the focal point for the first wave of co-innovation partnerships.

Building from the initial assessments, the internship will involve securing stakeholders' interest in participating and then producing specific action plans/capacity-building curriculum for the co-innovation partnerships. This may involve 'matching' countries in suitable partnerships or identifying 'host' countries/contexts that are exemplary of best practices in nutrition-sensitive social protection. The intern may be requested to travel to one or more participating countries for scoping visits and to make arrangements for operationalizing the co-innovation partnerships. The practicum experience would be based in GAIN's Washington DC office, and, ideally, would entail in person work in the GAIN office regularly at critical points.

The internship will be on a 3 months' fixed term contract basis. It will be on 32 working hours / 4 working days per week basis.

- Conduct a needs/opportunities assessment to better understand the ways co-innovation partnerships can be used to advance nutrition-sensitive social protection agendas/priorities.
- Support securing commitments from national and sub-national stakeholders (primarily government actors) to participate in the co-innovation platform.
- Contribute to drafting of specific action plans and capacity-building curricula for the co-innovation platform partnerships
