The Global Alliance for Improved Nutrition (GAIN) is a Swiss-based foundation launched at the UN in 2002 to tackle the human suffering caused by malnutrition. Working with both governments and businesses, we aim to transform food systems so that they deliver more nutritious food for all people. In particular, we aim to make healthier food choices more desirable, more available, and more affordable. GAIN's mission is to advance nutrition outcomes by improving consumption of nutritious and safe food for all people, especially the most vulnerable to malnutrition.

GAIN's purpose is to advance nutrition outcomes by *improving the consumption of nutritious and safe food* for all people, especially those most vulnerable to malnutrition. In particular, we aim to improve the consumption of safe and nutritious foods for—at a minimum—1 billion people over the next 5 years and target major improvements to the food system- more diverse and healthier diets - for vulnerable citizens in countries where we work.

GAIN believes the challenge is to *transform* food systems so that they do much more to improve the consumption of safe nutritious food by the people who need it most. Indeed, transforming our food systems to make them work better for people's nutrition and health is one of the biggest challenges facing humanity in the 21<sup>st</sup> century. This challenge has framed our three interlinked strategic objectives:

- 1. to improve the demand for safe and nutritious foods,
- 2. to increase the availability and affordability of safe and nutritious foods, and
- 3. to strengthen the enabling environment to improve the consumption of safe and nutritious foods.

GAIN is expanding its efforts to improve the diets of low-income, high-need consumers in the countries we work in. Social protection programmes are critically important for improving the livelihoods and purchasing power of vulnerable consumers, and nearly all such mechanisms have the potential to improve nutrition and diet quality.

Social protection schemes help to mitigate vulnerability, reduce poverty, and provide affordable healthcare and insurance to low-income families. GAIN's social protection approach emphasizes community-based approaches, human-centred design, and social and behaviour change as tools for enhancing the nutrition impact of social protection. In Pakistan, GAIN will support the Government of Pakistan's efforts those aim to enhance resilience of vulnerable groups confronted with economic shocks, reduce poverty and inequality, create opportunities for upward social and economic mobility and enhance social cohesion by mainstreaming the marginalized individuals. Our approach will complement existing government efforts to achieve Sustainable Development Goal (SDG) 1.3 through creating an environment of more inclusive social protection system.

As GAIN works to develop and implement an organizational strategy for social protection, partnerships with governments and policy advocacy will be central a central focus. GAIN Pakistan intends to hire a Senior Associate, Social Protection, under the leadership of policy & portfolio leads and in close collaboration with the Social Protection programme lead, to carry out our social protection policy advocacy & operational work.



## DESCRIPTION

#### **Overall purpose**

The Senior Associate, Social Protection has overall responsibility for the day-to-day operational delivery, implementation, and monitoring of Pakistan's Social Protection projects, specifically focusing on tracking the progress and status of project activities. They play a coordination role in GAINs cross-functional project teams and supporting the maintenance of relationships with partners and stakeholders. They are responsible for managing engagement with key in-country government stakeholders and other partners on matters related to the Social Protection programme. This position will also support coordination of Pakistan's social protection projects with GAIN's global social protection vision and strategy. The successful candidate will be tasked with leading and managing social protection project activities at the country level, contributing to key project deliverables, and effectively communicating findings to diverse and cross-cultural audiences.

#### Tasks and responsibilities

## **Project Coordination, Planning, and Implementation**

Under the guidance of Portfolio lead,

- Managing the project schedule, activity plan and planning milestones, supporting the tracking of
  progress and deliverables from project partners and implementing countries
- Collaborate with the global Social Protection programme lead on the design and planning of project activities and objectives
- Lead content development for Pakistan's social protection contribution to donor reports and other deliverables, such as case studies, academic articles, and media/social media materials
- Leverage technical expertise to inform and advise Pakistan's work in social protection policy areas and implementation of related activities
- Liaise with GAIN's global Social Protection programme by supporting strategy development and planning, to ensure coherence with the organization's social protection vision and aims
- Any additional responsibilities related to project Implementation

## **Policy analysis**

Under the guidance of Senior Policy Advisor,

- Aggregate and synthesize evidence on the social protection policy landscape in Pakistan and provide policy insights to gap analysis activities and prepare reports on the gathered evidence
- Create and manage a repository of policy documents that are relevant to social protection in Pakistan
- Spearhead social protection policy and advocacy agenda-setting under the guidance of the Senior Policy Advisor for nutrition-sensitive social protection programmes, including development of policy guidance and recommendations (e.g. policy briefs, factsheets, presentations) for use at global- and country-level
- Any additional responsibilities related to Social Protection Policy and Influencing as mutually agreed with line manager

## Stakeholder engagement and influencing

Under the guidance of Portfolio lead,

• Conduct stakeholder analysis and needs mapping in Pakistan



- Engage/consult relevant stakeholders to develop novel messaging tactics and outreach channels to reach to the most vulnerable/in needs.
- Build and maintain strategic engagement with stakeholders in the policy space, particularly federal government agencies, NGOs, and social protection/safety net schemes
- Organize and support influencing activities, including in-person events and webinars, convening and consultation meetings etc.
- Conduct advocacy activities to make SP more nutrition sensitive by policy makers.
- Develop PowerPoint presentations and relevant briefing documents to support stakeholder engagement and influencing.

## Research, Monitoring and Evaluation

- Assess possible impacts of enhancements to SP mechanisms, including nutrition outcomes and cost-benefit analysis.
- Manage monitoring and evaluation of social protection projects in Pakistan in order to share learnings and results across GAIN's Social Protection programme teams and other relevant stakeholders
- Contribute as part of a multi-country team to global research and indicator development projects
